The Chesterfield County Board of Supervisors will hold a public hearing on March 26, 2014 in the County Public Meeting Room located in the Chesterfield Administration Building, Rt. 10 & Lori Rd., Chesterfield, Va., to accept public comment regarding the real estate tax rate for tax year 2014.

This assessment may be appealed to the Department of Real Estate Assessments by requesting, completing and returning the application for appeal form available from the Department of Real Estate Assessments. The completed form with the supporting documentation must be postmarked or received by the Department of Real Estate Assessments no later than **March 15**, as required by the County Code.

This assessment also may be appealed to the Board of Equalization of Real Estate Assessments, or BOE, by requesting, completing and returning the BOE notification form available from the Department of Real Estate Assessments. The completed form, along with all supporting documentation must be postmarked or received by the BOE no later than **April 15**. The BOE will conclude all reviews of assessments by June 15.

APPEALING TO THE DEPARTMENT OF REAL ESTATE ASSESSMENTS IS A PREREQUISITE TO APPEALING TO THE BOARD OF EQUALIZATION. All dates and prerequisites are required by the County Code.
